1) In the event that any of the above contact persons cannot be reached, I hereby give permission for my child to receive any necessary emergency medical care or treatment decided on by a teacher of EcoKids Pre-school and I will assume responsibility for the payment for such care or treatment.

2) I, the undersigned, Hereby, apply for my child to be admitted to EcoKids.(hereinafter 'the school')

3) My child will attend the school which shall operate in conjunction with 'private school terms' which consist of a three term year.

4) Understand and confirm that in the event of my application being successful, the principal or any other person duly authorised by her is fully authorised to act in loco parents in any manner and at any time during which I shall have entrusted my child to the care of the school.

5) Undertake to pay the school fees as stimulated per term which amount may be increased subject to one term's notice. I shall give ONE term's notice in writing of any intention to remove my child from the school and in the event that such notice is not given, I shall remain liable for any fees in respect of the current term in which the child ceases to attend school as well as the following term's fees in lieu of such notice. I acknowledge that full school fees are payable in advance for each term, irrespective of whether any holidays, public holidays or breaks fall within the year, and any overdue amount shall attract interest calculated at prime as charged by the school's bankers from time to time.

6) Acknowledge that the school shall not be responsible for any loss or damage whatsoever and howsoever arising which I or my child/ children may sustain arising out of any loss/ injury whilst in the care of the school, it's staff or servants, and further undertake not to sue the school nor any member of it's staff or servants for any injury or damage or loss whatsoever that may be sustained in this connection. I further understand that while reasonable effort will be made to prevent losses or damage to my child's clothing or possessions, the school cannot accept liability for such and I undertake to insure myself against such losses.
